SPRINGFIELD COUNTRY CLUB MEMBERSHIP CLASSIFICATIONS

Family:

Shall include golfing, locker room, pool and dining privileges to a man or woman and his/her spouse/domestic partner living in the same household, 40 years of age and older. There shall be no restrictions on tee times for the Primary Member or spouse/domestic partner however, restricted tee times shall apply to children being under twenty-one years of age and living in the same household or any child under twenty-four years of age and a full-time undergraduate student living in the member's household. They will have the privilege of using the Club's facilities mentioned above pursuant to the rules and codes of dress, conduct and Junior Golfing Program as outline in this book.

Family (30-39):

Shall include golfing, locker room, pool and dining privileges to a man or woman and his/her spouse/domestic partner living in the same household, ranging from ages 30-39. There shall be no restrictions on tee times for the Primary Member or spouse/domestic partner however, restricted tee times shall apply to children being under twenty-one years of age and living in the same household or any child under twenty-four years of age and a full-time undergraduate student living in the member's household. They will have the privilege of using the Club's facilities mentioned above pursuant to the rules and codes of dress, conduct and Junior Golfing Program as outlined in this book.

Single:

Shall include golfing, locker room, pool, and dining privileges to a person 40 years and older. There shall be no restrictions on tee times. Dining and pool privileges only to a man or woman and his/her spouse/domestic partner and their children which, children being under twenty-one years of age and living in the member's household or under twenty-four years of age and a full-time undergraduate student living in the member's household. There are no golfing privileges to the Social members in this category.

Single (30-39):

Shall include golfing, locker room, pool, and dining privileges to a person 40 years and older. There shall be no restrictions on tee times. Dining and pool privileges only to a man or woman and his/her spouse/domestic partner and their children which, children being under twenty-one years of age and living in the member's household or under twenty-four years of age and a full-time undergraduate student living in the member's household. There are no golfing privileges to the Social members in this category.

Weekday:

Shall include weekday golf, pool, and dining privileges to the primary member. This membership also includes, pool and social privileges to his/her spouse and their children which, children being under twenty-one years of age and living in the member's household or under twenty-four years of age and a fulltime undergraduate student living in the member's household.

Junior 1 (13-20 years of age):

Shall include golf, pool and dining privileges to an individual aged 13 to 20, pursuant to the Club rules and codes of dress, conduct and any Junior Golfing Program in effect. Restricted tee times shall apply. This membership also includes dining privileges only to the sponsoring parent. (Please fill out the Junior 1 membership application)

Junior 2 (21-29 years of age):

Shall include golfing, locker room, pool, and dining privileges. There shall be no restrictions on tee times. Dining and pool privileges only to a man or woman and his/her spouse/domestic partner and their children which, children being under twenty-one years of age and living in the member's household or under twenty-four years of age and a full-time undergraduate student living in the member's household. There are no golfing privileges to the Social members in this category.

Social 3 Membership: (Limited Golf)

Shall include pool, and dining privileges to a man or woman and his/her spouse/domestic partner and their children which, children being under twenty-one years of age and living in the member's household or under twenty-four years of age and a full-time undergraduate student living in the member's household. Two primary members (excluding children) of this membership shall have golfing privileges of two rounds per month during restricted tee times (Monday through Friday) excluding holidays or tournament play. Payment of cart rentals is required. Driving range is not included, but may be added to this category for an additional fee. All members in this category may not play on weekends or holidays as a guest or otherwise.

Social 2 Membership: (Dining & Pool):

Shall include pool and dining privileges to a man or woman and his/her spouse/domestic partner and their children which, children being under twenty-one years of age and living in the member's household or under twenty-four years of age and a full-time undergraduate student living in the member's household.

Social 1 Membership: (available for a limited time)

Shall include pool, and dining privileges to a man or woman and his/her spouse/domestic partner and their children which, children being under twenty-one years of age and living in the member's household or under twenty-four years of age and a full-time undergraduate student living in the member's household. Two primary members (excluding children) of this membership shall have golfing privileges of two rounds per month to include weekend play any time after 2 p.m.

Payment of cart rentals is required. Driving range is included with this membership.

Dining Membership:

Shall include dining privileges only to a man or woman and his/her spouse/domestic partner. This category is eligible to add range status, but is not eligible for Emeritus status.

Non-Resident Membership:

Shall include golfing, pool, and dining privileges to a man or woman and his/her spouse/domestic partner and children which, children are under twenty-one years of age and living in the member's household or under twenty-four years of age and a full-time undergraduate student living in the member's household, provided that the member and his/her family are domiciled year round more than 50 miles from the Springfield Country Club. Tee times are unrestricted for all family members over twenty-four years of age but must be arranged through the Club Professional at least twenty-four hours prior to play. Non-resident Members may play no more than twelve rounds of golf per year and shall pay all appropriate greens fees and cart fees. Each round by a guest or family member will be included in the twelve round limit.

Clergy:

Shall include golfing, pool, and dining privileges to a Member of the clergy. Tee times are unrestricted.

Military Membership:

In recognition of our veteran's, this membership shall be granted to any active military member. Members in this membership shall receive 25% off the current dues structure.
